Preparing for the WIOA Regulations Regional Meetings

Before the Regional Meetings

*****Do not wait to read the regs; you will not have time to read at the meeting**

- 1. READ** the sections of the regs and law identified on the attached worksheet **BEFORE** you arrive at the regional meeting
- 2. FILL OUT** the attached worksheet **BEFORE** the regional meeting noting the following for each item:
 1. How the proposed reg will impact your state
 - a. Negative: challenges and complications it will cause
 - b. Positive: how it will support your services
 2. How the proposed reg should be edited or changed to avoid the negative impact on your state.
- 3. DOWNLOAD** on your tablet or notebook computer from [http://www.ncsdae.org/legislation and Funding.html](http://www.ncsdae.org/legislation_and_Funding.html) the following and bring them with you for easy reference:
 1. The regs
 2. The federal register
 3. A copy of WIOA
 4. The tables of content for each.
 5. And the following attachments to this email:
 - a. The revised May 18 2015 worksheet attached to this email, and
 - b. The National Governors Association (NGA) “Seeking Comments” document which is attached to this email.
- 4. REVIEW** the attached National Governors Association “Seeking Comments” issues and note any additional issues we need to address.

During the Regional Meeting

During the regional meetings, we want to capture the impact of each proposed regulation on each state. Therefore we will divide into small groups of three or four for discussion of what you entered in your worksheet (ergo, fill out the worksheet ahead of time).

We will then capture each state's input on a master worksheet matrix.

After the Regional Meetings

By May 29, and sooner if possible, you will receive

- the final compiled worksheet matrix
- a suggested format for responding to the proposed regulations and
- the procedure for submitting your responses.

Share your responses with your local programs and ask them to submit responses also (the more responses, the more DOL and ED must attend to them) by June 15.

Review the responses and prepare and submit your responses by June 15.

NOTE: This email is sent to all state directors and staff even if you cannot attend the regional meetings in hopes they will help you respond to the proposed regulations.
